THAT THE COUNCIL OF THE CITY OF WELLAND approves the award to Spriet Associates London Limited for the provision of the Cooks Mills Feasibility Study, as detailed in RFP24-09.

RELATIONSHIP TO STRATEGIC PLAN:

This recommendation is aligned to Council's strategic priority of ensuring "**Health and Wellbeing**" to promote personal health and well-being by offering an abundance of activities that meet the diverse needs and interests all while, advocating for improved health care throughout the city, and supporting the need for safety and security.

EXECUTIVE SUMMARY:

The City of Welland is committed to fostering a healthy and inclusive environment that reflects the evolving needs and aspirations of its residents. Investing in the Cooks Mills Feasibility Study is a proactive step towards ensuring that our community continues to thrive by offering high-quality, accessible recreational, and social spaces. This study is a foundational element in our longterm strategic plan to create sustainable, high-quality public spaces that will serve the community for generations to come.

BACKGROUND:

The Cooks Mills Community Hall and adjacent structures, originally constructed in 1966, were assessed in 2022 through comprehensive Building Condition Assessments. These assessments revealed that the buildings are in poor condition, requiring significant upgrades or potential redevelopment to maintain the level of service expected by the community. Given the City's population growth and changing demographics, it is essential to evaluate the current and future needs of the Cooks Mills site to provide facilities that serve the community effectively.

The Cooks Mills Needs Study and Preliminary Design will explore options for decommissioning existing structures, designing new facilities, and developing park areas that align with the community's needs. This study will also provide critical information to guide the City in making informed decisions about the future of these facilities.

DISCUSSION:

The City of Welland issued RFP24-09 Cooks Mills Needs Study and Preliminary Design competitively on Biddingo June 14, 2024. The proposal closed on July 28, 2024, and the City of Welland received five (5) compliant proposal submissions:

Staff from Community Services evaluated the compliant proposals on deliverables, project understandings, methodology, work plan, experience, and price. Based on these criteria, staff is recommending Spriet Associates London Limited.

The feasibility study will include multiple opportunities to gather resident and stakeholder feedback through a variety of methods.

FINANCIAL:

As shown above, Spriet Associates London Limited is the highest-scoring proponent and is recommended for an award.

RECOMMENDATION:

THAT THE COUNCIL OF THE CITY OF WELLAND direct staff to enter into a contract with GEI Consultants, Inc. to provide Consulting Services to Complete CLI ECA Reporting and Documentation Requirements at a cost of \$122,765.00 (excluding HST).

RELATIONSHIP TO STRATEGIC PLAN

This recommendation is aligned to Council's strategic priority of ensuring "Environmental Stewardship" to protect the ecosystems through a responsible approach to minimize the impact on the environment through supportive decision-making, professional processes, incentives, policies, and operational practices.

EXECUTIVE SUMMARY:

A request for proposal (RFP) was issued for consulting services to assist with the new consolidated linear infrastructure environmental compliance approval (CLI ECA) reporting and documentation requirements. GEI Consultants, Inc. scored the highest after the technical and pricing evaluation out of six (6) submittals. Staff consider the firm's abilities satisfactory and in accordance with City specifications and standards, and therefore recommends the firm be awarded the contract.

BACKGROUND:

The consolidated linear infrastructure environmental compliance approval (CLI ECA) is an update to the approval process replacing the need for multiple

individual approvals when modifying the municipal sewage collection system and/or the stormwater management system. This change was implemented by the Ministry of Environment, Conservation and Parks (MECP) to facilitate the development of important infrastructure projects more quickly and efficiently while maintaining high environmental standards.

The introduction of the new CLI ECA processes has necessitated changes related to municipal reporting and documentation requirements and include the following:

Municipal Sewage Collection System CLI ECA Requirements:

- 1. Operation and Maintenance Manual
- 2. 2024 Annual Performance Report (Wastewater)
- 3. Assessment of Conformance to Procedure F-5-1 and F-5-5
- 4. Collection System Overflows Transition from Annual to Event Based Monitoring and Reporting

Municipal Stormwater Management System CLI ECA Requirements:

- 5. Operations & Maintenance Manual
- 6. 2024 Annual Performance Report (Stormwater)
- 7. Municipal Sewershed Boundary Mapping

DISCUSSION:

To assist with the new CLI ECA reporting and documentation requirements staff prepared and released *RFP24-11 Consulting Services to Complete CLI ECA Reporting and Documentation Requirements* on Monday, July 8, 2024, and publicly advertised and posted with a major Canadian tendering website for a four (4) week period.

Six (6) proposals were received on closing day, Tuesday, August 6, 2022. A staged evaluation was performed as per the requirements of the RFP and the received proposals were first evaluated on technical merit alone, by a team of three (3) engineering staff. After technical review the proposal advanced to the pricing evaluation.

Below is a summary of the final scoring after final evaluation out of 100:

GEI Consultants (GEI) had the highest score after the final evaluation and has the required experience and resources to provide consulting services to complete the CLI ECA reporting and documentation requirements. They are also accustomed to working with both the City's wastewater and stormwater models. Staff consider the firm's abilities satisfactory and in accordance with City specifications and standards, and therefore recommends that the firm be awarded a contract.

FINANCIAL:

All project costs and funding for the study are summarized below.

The total anticipated cost of the project plus 1.76% HST is \$124,925.66. The approved 2024 Capital Budget for the CLI ECA Reporting and Documentation requirements is sufficient to cover the costs. The remaining funds in the account will be used to complete additional CLI ECA requirements if needed.

CONCLUSION:

The CLI ECA is a new, streamlined approval process by the Ministry of Environment, Conservation and Parks (MECP). It simplifies the approval process for modifying municipal sewage and stormwater systems, aiming to speed up infrastructure projects while maintaining environmental standards.

The new process also introduces additional reporting and documentation requirements. To meet these, the City issued RFP24-11 for consulting services. GEI Consultants, Inc. scored the highest in the evaluation and, given their satisfactory past work with the City, staff recommend awarding them the contract.

THAT THE COUNCIL OF THE CITY OF WELLAND accepts for information the successful award from the Province of Ontario of \$1.72M from the Building Faster Fund; and further

THAT Council approve the reallocation of the \$874,300 rate support portion of funding from the 2024 First Street Infrastructure Renewals project (Phase 1) to progress Advanced Metering Infrastructure and that the remaining balance is transferred to the capital surplus reserve fund as outlined in the report.

RELATIONSHIP TO STRATEGIC PLAN

This recommendation is aligned to Council's strategic priority of ensuring **"Environmental Stewardship**" to protect the ecosystems through a responsible approach to minimize the impact on the environment through supportive decision-making, professional processes, incentives, policies, and operational practices.

EXECUTIVE SUMMARY:

The City of Welland received \$1.72 million from Ontario's Building Faster Fund (BFF) for exceeding its 2023 housing target by 276%. The city submitted an investment plan, focusing on the First Street infrastructure renewal project, which includes developing six affordable townhomes and a supportive living residence. The Ministry approved the plan on August 13, 2024.

Phase 1 of the First Street project had previously received funding, and the BFF grant allows the city to reallocate this funding to a new project without affecting ratepayers. Staff propose reallocating the \$874,300 of previously approved rate supported funding to install Advanced Metering Infrastructure (AMI) for water meters, enhancing efficiency and service delivery. The AMI system will enable automated water usage data collection, increased billing frequency, and improved detection of issues like leaks. The cost for the required 8-15 towers ranges from \$30,000 to \$50,000 each. The remaining funds will go to the capital reserve for future projects.

BACKGROUND:

The City of Welland was awarded \$1.72 million dollars from the Province of Ontario through the Building Faster Fund (BFF) for exceeding our 2023 housing target by 276%. As a condition of the funding, the City of Welland was required to submit an investment plan for use of the BFF funding, including intended outcomes such as how the funding will contribute to increasing housing supply, housing development and/or address issues of housing affordability. Projects were required to focus on activities planned for the coming year/immediate funding cycle and should be tender-ready.

The project selected and submitted to the Ministry of Municipal Affairs and Housing for approval was the First Street full linear infrastructure renewals (see attached BFF Investment Plan). In addition to being tender-ready this project satisfies the Ministry's housing criteria given that two Habitat for Humanity properties within the limits are proposed to be developed into six (6) affordable street townhomes and a supportive living residence. The Ministry approved the City's BFF Investment Plan on August 13, 2024 (attached).

DISCUSSION:

The First Street project consists of two blocks, King Street to Plymouth Road (Phase 2) and Plymouth Road to Dover Road (Phase1). Phase 1 previously received construction funding during the 2024 budget deliberations. The BFF grant provides an opportunity to reallocate the previously approved funding to a new project without any impact to Welland ratepayers. Staff recommend that the rate supported funding previously approved for Phase 1 of the First Street project be redirected to progressing the City's move to a smart water network through the installation of Advanced Metering Infrastructure (AMI) or fixed in place gateway collectors (towers) that will receive residential water meter data.

Recall that once all residential water meters have been upgraded to RF technology, the goal is to increase meter read frequency. This can be achieved through the installation of gateway collectors (towers) in strategic locations throughout the city. The number of towers needed to read the majority of residential RF meters will be determined through a propagation study. It is anticipated that between 8-15 collectors will be required. The cost of each tower will depend on the difficulty of the installation but may range between \$30,000-\$50,000 each.

In addition to aligning with the City's strategic objectives around embracing new technologies to improve efficiencies and service delivery, the following benefits are expected to be achieved through the implementation of AMI:

- Fast and frequent automated collection of water usage data without human error.
- Increased billing frequency for residents with significant reduction in estimated bills.
- Daily data provides better oversite of water network and increases response time to meter read anomalies including, leaks, backflow or no-flow and potential meter tampering.

• Future opportunity to implement customer portal so that customers can monitor their own water consumption and catch leaks before an expensive bill.

Staff will provide future AMI updates to members of Council once the propagation study is complete.

FINANCIAL:

The 2024 capital funding approved for Phase 1 of the First Street Infrastructure Renewals is summarized as follows:

In accordance with the approved Investment Plan, \$1.2M of the City of Welland's 2024 BFF monies will replace the funding above. Staff propose the reallocation of the previously approved rate supported funding to progress AMI technology. Given that the project will be funded by the BFF grant, the Debenture amount of \$310,300 is no longer required and that the remaining balance of \$78,900 will be transferred to the Capital Surplus Reserve fund.

The total previously approved rate supported funding available to be redirected to AMI is, \$874,300. Conservatively, 15 towers at a cost of \$50,000 each would be \$750,000.

CONCLUSION:

The Ministry of Municipal Affairs and Housing approved the City's BFF Investment Plan, specifically the First Street Infrastructure Renewals project given that the project is tender-ready and supports the development of six (6) affordable street townhomes and a supportive living residence.

Staff propose reallocating the rate supported portion of the funding that was previously approved in 2024 for Phase 1 of the First Street project to progress Advanced Metering Infrastructure that will provide fast and frequent automated data collection and enhance the accuracy and efficiency of water usage monitoring.

\$1.2 million of the City of Welland's 2024 Building Faster Funds (BFF) will be used toward Phase 1 of a 2 Phase full linear infrastructure renewal project on First Street between King Street and Dover Road which will include the following infrastructure replacements:

- 595m 150mm dia. cast iron watermain circa 1905-1913 to be replaced with a 150mm dia. PVC watermain;
- 370m 200mm dia. vitrified clay sanitary sewer circa 1905 to be replaced with a 200mm dia. PVC sanitary sewer;
- 240m 300mm dia. vitrified clay sanitary sewer circa 1913-1941 to be replaced with a 300mm dia. PVC sanitary sewer;
- full road reconstruction including granular base, asphalt, subdrain, concrete curb and gutter and sidewalk on one side of the roadway.

Phase 1 will be done on First Street between Plymouth Road and Dover Road. The remaining \$460,000 will be used in 2025 along with the anticipated 2025 BFF to help fund Phase 2 of this project. The cost of phase 2 is anticipated to be \$2,101,000.00 full The existing linear infrastructure is well past its expected service life. Therefore, the proposed infrastructure renewals are critical to support the development as described below to ensure capacity, performance and service reliability.

Phase 1 of this project contains properties designated Institutional, and others designated Low Density Residential. Two properties known as 54 & 68 Plymouth Road were sold by the City to Habitat for Humanity Niagara for the construction of 6 affordable street townhouses and a supportive living residence. The properties have a lot area equal to 1713.84 square metres. These projects cannot proceed forward without the upgraded water and sewer mains on First Street.

Phase 2 of the project contains properties is designated Health and Wellness Cluster and zoned INSH – Insitutional Health and Wellness which permits high density residential development. There is approximately 2.8 hectares of developable land which would help create the potential for a minimum of 350 new dwelling units or more over time.




